Draft Minutes of X3J14 Meeting #8

ANS Forth Technical Committee May 3-6, 1989, Boston, Mass. Doc. no: X3J14/89-006

Call to Order

Ms Rather welcomed the X3J14 Technical Committee and established that a quorum was present. There were 15 voting members present. The attendance list is document 89-007. Mr. Tracy is an observer at this meeting. Mr. Duncan sent a letter explaining his absence, and Mr. Bailey sent a list of comments on technical proposals.

The minutes of X3J14 Meeting #7 were corrected and adopted as amended. The agenda for this meeting was approved unamended by voice vote.

Action Item Review From Meeting #7

- 1. The BASIS is now date stamped.
- 2. The mailing list was corrected.
- 3. Ms. Rather has written to the Forth Standards Team.
- 4. Mr. Tracy called Mr. Rodriguez.
- 5. We have clearly been in contact with Boston FIG, and they have ordered a number of BASIS's from us.
- 6. \$30 annual subscription has been well received. 30 copies have been sold, 10 of them subscriptions, including Palo Alto Shipping Company, Miller Micro Systems, plus groups and individuals in Taipei, England, Australia, Canada, etc.
- 7. Done.
- 8. Done.

The burning issues from the last meeting were reviewed. Ms. Rather pointed out X3/SD-9 has been sent out and that we can expect that X3 will expect our dpANS to conform to it. Mr. Nemeth questioned how the requirements concerning comparisons with prior standards could be applied to new standards. Ms. Rather suggested we consider Forth-83 to be an existing standard.

Logistics Committee Report

Mr. Shaw suggested that the next meeting could be in Hawaii rather than Berkeley. Mr. Stevenson suggested Reno, Nevada. Ms. Rather reminded us that there is a very active Northern California FIG group. In the following discussion it developed that airfares to Hawaii can be gotten almost as cheaply as airfares to San Francisco, but that they sell out early. The August meeting is July 26-29, probably in Berkeley, with Mr. Shaw as the host. The following meeting is October 25-28, in Washington, D.C., with Don Colburn hosting. Ms. Rather will investigate a Hawaii site for the January 1990 meeting. It was noted that interested Japanese and other Pacific Rim guests could be accommodated.

Documentation Committee Report

Mr. Dickens reported that there was no concordance, and that the BASIS was three weeks late. He recommends that we not accept late entries to BASIS, and that Mr. Braithwaite be taken out of the loop. We need a general plan to go from BASIS to dpANS, as soon as technical issues are covered. Refer to the SNAP document in the two-week mailing.

BASIS 7 was adopted 14/0.

Research Committee Report

Mr. Nemeth reported that both field trials failed to launch. Mr. Colburn has lost interest in forming the local variables document. Neither Mr. Sanderson nor Mr. Bailey have been able to handle the compilation issue packet. Furthermore, the Palo Alto Shipping Company was the only volunteer outside of this committee. Mr. Shaw said he had a list of several hundred volunteers through ACM.

Mr. Tracy moved to cancel field trials and return all materials to the Technical Subcommittee. Passed 14/0.

Technical Subcommittee Report

Mr. Bailey was unable to attend this meeting. Mr. Tracy will be the TSC chair in his absence.

International Subcommittee Report

There was no International Committee report. Mr. Dorband has not yet succeeded in arranging sponsorship.

Other Business

Mr. Duncan, in his letter, stated his concern that we present a unified front in the face of criticism in the Northern Californian FIG community and on GENIE. Mr. Shaw felt that these criticisms were exaggerated and will not present a problem. This led to a general discussion on how to reach the Forth community. Mr. Hayes volunteered to write a column for Forth Dimensions explaining the technical aspects of the issues. This passed as a motion by voice vote. Mr. Kobziar moved that we make available at the Rochester Forth Conference a list of members willing to explain the issues directly on the phone. The following members volunteered:

Mr. Keane was greatly concerned that documents sent after the two-week mailing have been acted on. He interpreted X3 documents to say that this deprived members not present at a meeting from their right to vote on an issue. Mr. Dickens called X3 and reported that only members present at a meeting can invoke the two-week rule. Mr. Dickens moved that all new proposals be automatically two-weeked. This motion failed 2/11. Mr. Keane invoked the two-week rule on everything. Ms. Rather ruled that it must be invoked on a case by case basis.
