# **Draft Minutes of X3J14 Meeting #11**

#### Call to Order

The chair extended thanks to John Wavrik for hosting this meeting.

The following guests and observers were introduced: John Wavrik, Matthew Costello (observing), Leonard Zettel (observer), John Latham. Guy Kelly returned after an absence.

The attendance list is document 90-003.

Tom Hand is on probation. The Chair noted that at the last meeting we accepted representation from two people who were not there, and who had designated alternates who were already TC members. In fact, their votes were not acceptable. For someone who is already a member to represent another organization requires direct approval from SMC. Charles Keane is therefore on probation, and Ray Duncan has lost his vote. Organizational members are strenuously urged to select an alternate. It is appropriate to have yourself represented at "odd coast" meetings.

The minutes of meeting 10 were approved by voice vote.

The X3J14 annual report was distributed, and was pretty much boiler-plate.

The annual report of the FVG was given. The income statement was distributed in the mailing. FVG continued to operate at break-even last year. Sales of BASIS went from \$300 to more than \$1700.

## **Logistics Committee Report**

Mr. Betts is working with Mr. Hand on the May 23-26 meeting, which will be in Florida. We will meet for 5 days to finish the technical phase of our meetings. Mr. Betts is still looking for a host for the Fall meeting. Mr Hayes is looking at the Johns Hopkins Advanced Physics Lab., but it's in a remote area. Other possibilities are CBEMA, U of Md, or a rustic retreat.

The Chair, after careful reading of SD-2 and other documents, concluded that there would be no problem holding a meeting in Canada.

# **Documentation Committee Report**

BASIS 10 was approved by voice vote. Mr. Braithwaite has indexed the document, which will add about 10 pages. It was moved to add it to BASIS 11, and approved by voice vote. Mr. Bailey's concordance has a short list of "buzz phrases," and anyone is welcome to add to them.

Mr. Braithwaite will be leaving for Africa, so we need a document editor, who will commit to approximately 8-10 hours at the end of each meeting. Mr. Betts volunteered.

# Research Committee Report

Mr. Shaw is working on another survey based on controversial proposals to be included with the next SIGForth newsletter. Additional questions to be included are welcome. The Chair commented that the small number of participants on the last GENIE forum seemed uncomfortable with locals.

# **Technical Committee Report**

Mr. Bailey reported that at the end of the last meeting we had 68 actionable proposals. Since then, we received 70 more that cannot be two-weeked, so about 140 are now actionable. The TC has 3 proposals in limbo: two are tabled, TP-166 and TP-453, and TP-210 (Globals and Locals) was postponed until this meeting. TP-210 was returned to the TSC by a vote of 12/3.

Mr. Bradley commented that "common practice" has been applied in this committee with emotion and inconsistancy. He moved to remove it as a requirement. Mr. Bailey asked whether any of our measures can be applied metrically. There was some discussion. Mr. Bailey noted that according to resolution 87-002, modifications are unacceptable if they deviate from what producers of more than 200 systems do. The motion to drop "common practice" failed from 87-002 failed 0/14/1.

### Other Business

- J. Wavrik addressed the committee expressing his concerns that we leave enough "hooks" for extensions so that extensions are not de facto required.
- L. Zettel also addressed the meeting. He stressed that we must consider the system as a whole. He explained that the Forth scene is a system of problems, i.e., a "mess." For example, the language described by *Starting Forth* does not match systems available from implementors. The domination of the committee by any faction will be bad for Forth as a whole.
- S. Pelc wrote requesting that lower-case "e" be acceptable in floating-point numbers, and wants COMPILE and [COMPILE] instead of POSTPONE. He also wants to make CONVERT obsolete and to add NUMBER, which converts a number of any form. He likes ALSO ONLY and would require it if he were to implement a standard.

Mr. Dickens resigned his positions as Chair of the Documentation Committee and as Vocabulary Representative.

TC overwhelmingly passed a resolution thanking Mr. Dickens for his outstanding work on the Documentation Committee.
